

## Terms and use conditions (June, 2020)

### General Provisions

- Dits is an electronic system with intellectual property and copyright registered in the name of QUASAR TELEMEDICINA DEVELOPMENT DE SISTEMAS COMPUTACIONAIS LTDA., Which was created based on scientific research and technological development that can be changed and improved at any time without the need for prior knowledge or authorization request to its Users.
- The Dits system provides monitoring and control of blood glucose levels at distance, from people with diabetes and / or obesity to the sending and receiving of data between doctors, nutritionists and patients using the system in a timely manner support the basal bolus therapy of insulinization and support the counting of carbohydrates, medication intake and diet therapy.
- The use of the Dits program will necessarily involve the exchange of information between Users and QUASAR TELEMEDICINA, some personal and sensitive.
- Before making the decision to join the Dits program, the User must know and consent to our Terms of Use and Privacy Policy.
- For the purpose of defining the terms used in this document, it is understood as Patient, the user who uses the Dits system for monitoring purposes their own food, medication, glycemic indexes and weight.
- For the purpose of defining the terms used in this document, it is understood as Physician, the health professional registered with the Regional Council of Medicine who adhere to the Dits system to monitor one or more Patients.
- For the purpose of defining the terms used in this document, it is understood as Nutritionist, the health professional registered with the CRN who joins the system Dits for monitoring one or more Patients.
- For the purpose of defining the terms used in this document, it is understood as Caregiver the user appointed by the patient, his

doctor or nutritionist to receive data and alarms from monitoring and treatment.

- For the purpose of defining the terms used in this document, it is understood as User or Nutritionist, Doctor, Patient or Caregiver who joins the system Dits.
- Personal data is understood as any information related to a person identified or identifiable.
- It is understood as sensitive personal data, those related to health and treatment of the holder.

## **Terms of use**

1. Dits is an intelligent electronic support system for action management which is limited to automating and recording calculations based on information provided by Users, and never prescribes or suggests values and or parameters, nor does it update any prescriptions.

2. The Dits system may be used by the Patient independently or under the supervision of a Doctor or Nutritionist, through the adherence and attachment of these within the Dits system.

2.1 - The patient using the system may send an invitation / permission to doctor or nutritionist registered in the system can assume their roles of prescriber and nutritional advisor.

2.2 - The Medical Patient or nutritionist can disconnect at any time and hour using the discharge procedure contained in the system.

3. Access to the Dits system is through an individual login and password, which is personal and non-transferable. Any damage resulting from the loss or provision of the personal password to third parties is the sole responsibility of the User.

4. Dits allows the patient to inform their circumstantial blood glucose levels, their foods, their medications and administered insulin doses, weight and makes available this information to the Doctor, Nutritionist and Caregiver linked to it, over the internet.

5. The Doctor, Nutritionist and Caregiver linked to a Patient will have free access to all the information entered by the Patient, in real time, including medical records and curves glycemica.

6. Any calculation or recommendation of insulin doses, obey a prescription provided and registered in the system always by the Doctor, who will be automatically updated in the Dits system for use when performing dose calculations of insulins by the patient.

7. From the moment a Patient has a Doctor or Nutritionist attached registered in the system, your prescription can only be provided or changed by this professional. The change of professional must be made through the request for discharge available in the system.

8. The use of the Dits system does not dispense or supply the need for regular monitoring of the health professional.

9. The responsibility for the veracity and updating of all personal data available in the system is the Patient. The Patient declares to be aware that the provision of untrue data or its outdated may have negative implications the results obtained by using the Dits program.

10. The responsibility for the adequacy of the prescriptions and dosages suggested to Patients is from the Doctor and / or Nutritionist who must be transcribed to the system by user or their caregivers.

11. It is hereby established that under no circumstances will the Dits system be responsible for any responsibility for any data, prescriptions, and / or dosages provided or mistakenly suggested.

12. The adhesion of the Doctor or Nutritionist to the Dits system is made through the acquisition of a license to use the Dits service, registration on the website itself and acceptance of Terms of use.

12.1 - Once the adhesion is made Doctors and Nutritionists will have the right to use unlimited for one year, after which the membership must be renewed

13. The cancellation of the Physician or Nutritionist's adhesion to the Dits system will occur at any time by request available on a link on the Dits website.

13.1 - When canceling the membership of the Doctor or Nutritionist to Dits, the this professional's patients will be automatically discharged from the system, remaining in use of their latest prescriptions

13.2 - When canceling the membership of the Doctor or Nutritionist to Dits, the Quasar will send to the email address registered by the professional, a file .csv containing data from your patients' medical records with their prescriptions and clinical developments.

14. The adhesion of Patients and Caregivers to the Dits system is made through the acquisition of access to the service in the network of authorized stores of the "Apple Store" and "PlayStore", registration of personal data and acceptance of the Terms of Use.

14.1. Once adherence is made, Patients and Caregivers will have the right to use unlimited for one year, after which the membership must be renewed.

14.2 - The use of Dits by patients under the age of 18 must be authorized by the Prescribing Physician or your Nutritionist or Nutritionist.

14.3 - The acquisition and or use of the Dits service by minors under 18 obeys the rules of commercialization of PlayStore and AppleStore responsible for the distribution of the service to patients.

15 - The cancellation of the adhesion of Patients and Caregivers to Dits will occur to any moment for the request available in link on the Dits website.

15.1 - When canceling his relationship with Dits the patient will receive in his email registered in the system a file in .csv format listing all your data  
medical and nutritional follow-up and prescriptions

15.2 - Cancellation of Dits membership by a Patient implies cancellation  
automatic participation of the Caregivers registered by him.

16. The Dits system is a virtual tool to support therapy, which is made possible by the use of a portal (website) on the world wide web (internet) and, occasionally, beyond our control, for technical reasons, it may be unavailable.

17. The processing of personal data made available in the Dits system respects the Policy Privacy Policy, available at Privacy Policy. By joining the system the User declares to have read and agreed with the Privacy Policy of the Dits system.
